Mr. O'Dowd presented a summary of the new report 'Campus Fire Fatalities in Residential Buildings (2000-2015).' While this report covers fatalities that occurred in all campus residential buildings, it reminds us that 94% of these deaths occurred in off-campus housing. This should give everyone incentive to try even harder than we already do.

As we head into the winter months we know the problems and risks that we will be faced with as the temperatures drop, but these aren't much different than other housing types in our communities. What is different is the party scene. Off campus parties are a main stay for many in college. I'm constantly reminded of the party risks in my community. Some landlords pay attention, others do not.
