

Fuel Storage for Stationary Engines for Emergency Generators

Introduction. In this sixth installment, I want to discuss some of the basic provisions for fuel storage for stationary internal combustion engines. I use the phrase "for emergency generators" in the title, but stationary engines are also used to provide motive power for fire pumps, water pumps, and electrical ...

CHAPTER 8 INTERIOR FINISH, DECORATIVE MATERIALS AND FURNISHINGS

SECTION 801 - GENERAL

801.1 Scope. The provisions of this chapter shall govern interior finish, interior trim, furniture, furnishings, decorative materials and decorative vegetation in buildings. Existing buildings shall comply with Sections 803 through 808. New buildings shall comply with Sections 804 through 808, and Section 803 of the International Building Code.
