The top 7 fire safety items you need to know about your commercial cooking operations.

Many colleges and universities have their own cafeteria as well as some nationally recognized franchises. Facility managers and restaurant managers are charged with protecting their facilities from a potential fire by complying with the minimum fire safety requirements adopted by the local jurisdiction. In a 2012 report titled, "Structure Fires in Eating and Drinking Establishments" by Ben Evarts, U.S. fire departments responded to an estimated average of 7,640 structure fires per year in eating and drinking establishments between 2006 and 2010. These fires caused an average annual loss of two civilian deaths, 115 civilian injuries and \$246 million ...

SECTION 903 AUTOMATIC SPRINKLER SYSTEMS (Part 1)

903.1 General. Automatic sprinkler systems shall comply with this section.

903.1.1 Alternative protection. Alternative automatic fire extinguishing systems complying with Section 904 shall be permitted instead of automatic sprinkler protection where recognized by the applicable standard and approved by the fire code official.

903.2 Where required. Approved automatic sprinkler systems in new buildings and structures shall be provided in the locations described in Sections 903.2.1 through 903.2.12. Exception: Spaces or areas in telecommunications buildings used exclusively for telecommunications equipment, associated electrical power distribution equipment, batteries and ...

Low-Frequency Sounders and NFPA 72, 2016 ...

In dormitories, hotels, assisted living facilities and other buildings with sleeping areas, a fire alarm system must be capable of awakening people who are sleeping. To help achieve that life-saving objective, NFPA 72: National Fire Alarm and Signaling Code now requires low-frequency alarm signaling in sleeping areas. That change was made because research has shown that low-frequency 520 Hz sounders are more effective at awakening people who are sleeping, including those who are hard of
