


LIFE SAFETY, FIRE SAFETY, SECURITY SAFETY: Blended, Balanced and Built In.

SECTION 604 EMERGENCY AND STANDBY POWER SYSTEMS

604.1 General. Emergency power systems and standby power systems required by this code or the International Building Code shall comply with Sections 604.1.1 through 604.1.8.

604.1.1 Stationary generators. Stationary emergency and standby power generators required by this code shall be listed in accordance with UL 2200.

Within the Incident Command System, Safety has always been the IC's responsibility, but in the past, it was a passive process that was touched-on during the tailboard critique after the fire. Work Place Safety was the term most used and it pertained to more of an Occupational Safety and Health Association check-off at the fire station. I know you remember the person responsible for this check-off saying, "Let's make sure those grinders at the stations have a guard on them."

Coming in September Fire Safety Regulations for Food Trucks Jacqueline Wilmot, Fire Protection Engineer at NFPA

This webinar will address the fire hazards associated with mobile food trucks and create awareness that not one code, recommended practice or standard addresses this issue as a whole to provide requirements for fire protection or life safety purposes for mobile food trucks. Fire Departments of major cities around the country are developing their own standard to solve this issue and prevent disasters from occurring in the future. The International Fire Marshals Association (IFMA) submitted public input to NFPA 1 and NFPA 96 to address this issue. At the time of the webinar an update will be provided based on the Technical Committees decisions during Committee Meetings from NFPA 1 and NFPA 96.



FIRE FATALITY STATISTICS

FIRE FATALITY STATS FROM USFA

The U.S. Fire Administration's Campus Fire Fatalities in Residential Buildings (2000-2015) report analyzes the 85 fatal fires that took place in dormitories, fraternities, sororities and off-campus housing which resulted in 118 fatalities - an average of approximately seven per school year.
