



Are We Ignoring 20 Percent of Our Population When We Plan for Evacuations? By Allan B. Fraser, CBI, CPCA, Senior Building Code Specialist, NFPA

Human factors play an important role in residential building fire fatalities and of course, college dorms are residential buildings. According to the NFPA report, "Human Factors Contributing to Fatal Injury Based on NFIRS 5.0 Field in Civilian Casualty Module" by Ben Evarts, June 2011, the leading human factor contributing is being "asleep" which is responsible for 30% of fatalities in home fires. The second leading human factors contributing to fatalities, is tied at 14 percent for "obviously disabled" and for alcohol or drug impairment. [MORE](#)



#### 909 Smoke Control Systems (909.7)

909.7 Airflow design method. When approved by the fire code official, smoke migration through openings fixed in a permanently open position, which are located between smoke-control zones by the use of the airflow method, shall be permitted. The design airflow shall be in accordance with this section. Airflow shall be directed to limit smoke


