### UNCOVERING THE VEIL OF SMOKE

### SECTION 504 ACCESS TO BUILDING OPENINGS AND ROOFS

You know what they say, knowledge is power. In this case knowing about fires and the dangers they bring can not only empower you to make safer choices but could help save your life.

**Dangers of Smoke ...** Many people know that smoke is hazardous, but some of the reasons why may surprise you. One of the more well-known perils is that smoke may contain toxins such as carbon dioxide and carbon monoxide as well as other particulates, which are not pleasant to inhale. Your body will let you know this by coughing, wheezing and if exposed for too long, incapacitation. Smoke also limits your visibility, which not only hinders your ability to identify exits and hazards, but individuals tend to move slower when they can't see where ...

504.1 Required access. Exterior doors and openings required by this code or the International Building Code shall be maintained readily accessible for emergency access by the fire department. An approved access walkway leading from fire apparatus access roads to exterior openings shall be provided when required by the fire code official.

504.2 Maintenance of exterior doors and openings. Exterior doors and their function shall not be eliminated without prior approval. Exterior doors that have been rendered nonfunctional and that retain a functional door exterior appearance shall have a sign affixed to the exterior side of the door with the words THIS DOOR BLOCKED...

## An interesting article ...

### Here's why Syracuse University won't have to change its smoke detector system following state legislation

Although a New York state law passed last month requiring all smoke detectors to have 10-year batteries, Syracuse University does not have to make any changes to its smoke detector system.

In a statement released by the New York State Assembly last month, New York state Gov. Andrew Cuomo required that all homes and businesses have working smoke detectors with 10-year batteries. The act takes full effect on Jan. 1, 2017, and applies to all buildings on the SU campus.

U.S. Fire Administration's Campus Fire Fatalities in Residential Buildings (2000-2015) Report

The U.S. Fire Administration's Campus Fire Fatalities in Residential Buildings (2000-2015) report analyzes the 85 fatal fires that took place in dormitories, fraternities, sororities and off-campus housing which resulted in 118 fatalities - an average of approximately seven per school year.
